Here's what has happened in the last month and what's to come!

The Safeguarding office has had a busy April. This year the office has to date provided 65 hours of onsite parish support and presented 47 hours of training.

Support does not only occur when we are face to face in parishes. On a day-to-day basis the Safeguarding team assist the Diocese, and its agencies and entities to continually improve safe practices, connecting our work with the National Safeguarding Standards.

In the months ahead there is a focus on supporting each parish to complete the **annual** Self-Assessment to the Safeguarding Standards. We will be in contact shortly to arrange our visit, in the meantime please feel free to contact our office to arrange your assessment timetable.

The April newsletter from Australian Catholic Safeguarding Ltd, reminds us of National Catholic Safeguarding Standard 9 that *"calls organisations to regularly review and strengthen their safeguarding systems to ensure they remain effective, responsive and fit for purpose"*.

New ACSL Complaints Line

From 1 April 2026, ACSL will operate a dedicated complaints phone line to make it easier for anyone to raise safeguarding concerns or complaints. You can contact the team confidentially on 1800 ACS LTD (1800 227 583).

This line supports National Catholic Safeguarding Standard 6 – Effective Complaints Management by providing a clear, accessible and responsive pathway for concerns to be raised. It ensures that complaints are received and managed in line with best practice principles, helping to promote transparency, accountability and trust.

This line is monitored by our Professional Standards and Complaints team during business hours, providing a safe, secure and accessible way for individuals to speak directly with us about concerns or matters requiring attention.

We ask for the courage to confront the causes of domestic violence, including the prevalence of violence in our society, any abuses of power.

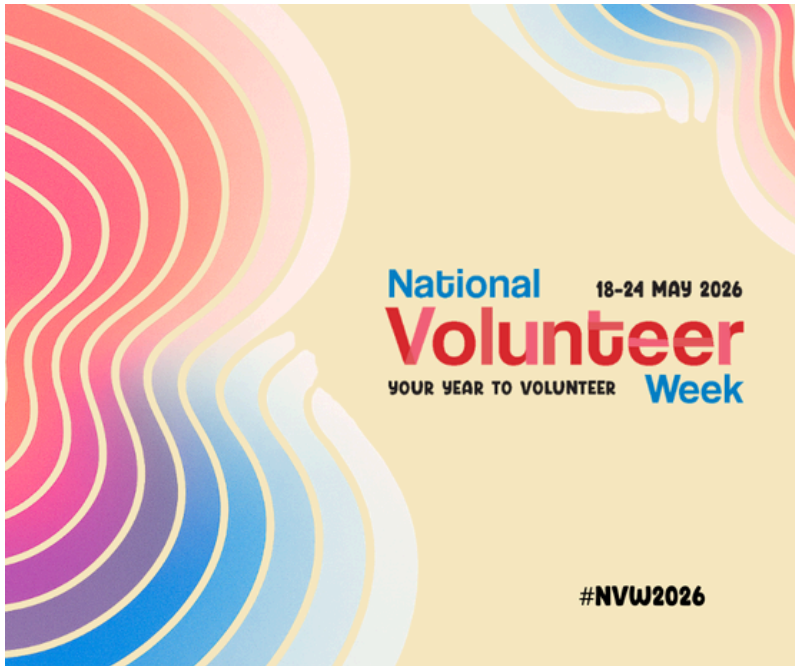
We long for the time you have promised, when violence is banished, women and men are open to being loved and loving others, children are protected, and the work and wealth of our world is justly shared.
